## 2. AGENDA ACTION ITEMS

#### 1. ACTION ITEM: Packsaddle Road Vacation & Dedication

Public Works Director Darryl Johnson presented the numerous attachments to the agenda item. Mr. Johnson recommended accepting the road dedication to remove the liability for the applicant, and then move forward with the reclamation.

Commissioner Riegel highlighted the changes made to the Escrow Agreement. An additional whereas was added to address the warranty period for reclamation, revegetation and weed control that includes Kay's Hill, to be one year starting from the acceptance of the dedication. The second change was to update paragraph 2 to reflect a completion deadline for the applicant to finish the revegetation by June 30th 2021 or the County can use the \$50,000 bond to complete the work.

The bond money will be deposited in the escrow account, held by Blake Hall's firm, once all signatures have been collected.

No questions regarding the Grant Deed document.

#### 2. MOTION: See motion below.

**Motion:** Approve the Escrow Agreement as presented securing a \$50,000 cash bond as required in the original

Packsaddle Road Agreement to Vacate and Relocate Road, as presented in item 1H with the following changes.

The addition of a sixth whereas that states WHEREAS, the warranty period for the reclamation, revegetation and weed control

under the 2017 Agreement is defined as one year after the abandonment of the existing County road and the acceptance and adoption of the new County road.

And modification of Paragraph 2 (pg 2) The Escrow Deposit shall be held in escrow for a period of one (1) year following the abandonment of the existing County road and the acceptance and adoption of the new County road dated December 30, 2021, as defined within the 2017 Agreement which is hereby incorporated by reference. All revegetation and reclamation work will be completed before June 30, 2021. If Landowners fail to finalize the revegetation and reclamation by June 30, 2021, the County shall make other arrangements for completion of said work and be entitled to be reimbursed from the Escrow Deposit. Upon expiration of the aforementioned one (1) year term, the Escrow Agent shall release the Escrow Deposit to the Landowners, less any issued disbursements to Teton County as outlined in Section 3.

Commissioner Heneage amended the motion correcting the date in paragraph 2 as December 30th, 2020. Commissioner Riegel accepted the amendment.
