



ORDINANCE NO.1216-2024

TETON COUNTY, IDAHO
ADOPTION OF THE AMENDED TETON COUNTY IDAHO NATURAL RESOURCE
OVERLAY (NRO) MAP

AN ORDINANCE ADOPTING THE AMENDED NATURAL RESOURCE OVERLAY MAP WHICH INCLUDES REVISIONS TO THREE OF THE FIVE NATURAL RESOURCE OVERLAYS: BIG GAME MIGRATION CORRIDOR AND SEASONAL RANGE, SHARP-TAILED GROUSE BREEDING HABITAT, AND WATERBIRD BREEDING, MIGRATION AND FORAGING AND WINTERING HABITAT; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Teton County Board of County Commissioners appointed a Wildlife Advisory Committee with Resolution 2022-0509B and the Committee reviewed current Idaho Fish and Game data with the finding that some layers of the Natural Resource Overlay maps needed revisions;

WHEREAS, the Wildlife Advisory Committee made a formal recommendation to update three layers of the Natural Resources Overlay Map: Big Game Migration Corridor & Seasonal Range, Sharp-Tailed Grouse Breeding Habitat, and Waterbird Breeding, Migration and Foraging and Wintering Habitat;

WHEREAS, the recommendation was considered under the Teton County Land Development Code (LDC) §4-4 and processed as a large-scale zoning map amendment;

WHEREAS, the Teton County Planning and Zoning Commission made a formal recommendation after holding a public hearing on May 14, 2024, and after a public hearing by the Board of County Commissioners (Board) to consider the proposed amendments to the NRO Map on October 18, 2024, the Board has made and does hereby make the following findings:

- 1) That the review criteria in LDC §4-4-F were met by the proposed NRO map revisions, and the revised NRO maps reflect the most current wildlife data available.
- 2) The revised Natural Resources Overlay Map is included as Exhibit A.

NOW, THEREFORE BE IT ORDAINED, by the Teton County Board of Commissioners as follows:

SECTION 1: The Natural Resource Overlay map is amended per the recommendation of the Teton County Wildlife Advisory Committee and is hereby adopted.

SECTION 2: All ordinances, resolutions or parts thereof in conflict herewith are hereby repealed, rescinded and annulled.

SECTION 3: This ordinance shall be in full force and effect from after its passage, approval and



publication, according to law.
